NOTICE FOR FYUG ADMISSION UNDER FINAL SPOT ROUND

All intending candidates seeking admission to the **Four-Year Undergraduate Programme (FYUG)** under the **Final Spot Round** are hereby informed to submit a **hard copy of their Samarth Application Form** at the **Biotech Hub, Srikishan Sarda College, Hailakandi, on or before 2:00 PM on 04-08-2026.**

No application shall be accepted after the stipulated time under any circumstances.

Candidates intending to apply for **more than one subject** must submit **separate hard copies** of the Samarth Application Form for each subject. They are required to **clearly write the order of preference (Preference-1, Preference-2, Preference-3, etc.) on the top right corner of each application form.**

Based on the applications received **up to 2:00 PM on 04-08-2026**, the College shall prepare **subject-wise merit lists** along with **subject-wise wait lists**, which will be published by the College.

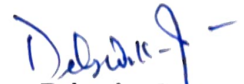
It is further notified that, in accordance with the College admission policy, **one-fourth (25%) of the vacant seats in each department shall be reserved for candidates who have passed the H.S. Second Year Examination from Srikishan Sarda College, Hailakandi.** They will be offered seats based on the merit in their final exam.

The admission schedule shall be as follows:

1. **04-08-2026 (up to 2:00 PM):** Submission of hard copies of Samarth Application Forms at the Biotech Hub.
2. **After scrutiny:** Publication of subject-wise merit lists and wait lists by the College.

3. **05-08-2026:** Candidates whose names appear in the merit lists must complete their admission formalities within the stipulated time. **Failure to take admission on 05-08-2026 shall result in automatic cancellation of the candidate's claim to the seat. No request, representation, or excuse for extension of time shall be entertained by the College.**
4. **06-08-2026:** The College shall assess the vacancies arising after the completion of admissions from the merit list. Eligible candidates from the respective **wait lists** shall be offered admission against the vacant seats.
5. **07-08-2026:** If any seats still remain vacant in any department, the concerned department shall take appropriate steps to fill up the remaining vacancies in accordance with the applicable admission guidelines and the decision of the College.

All candidates are advised to follow the above schedule strictly and regularly visit the College Notice Board and official website for updates. The College shall not be responsible for any claim arising out of failure to comply with the notified schedule.
